自二零一二年一月, 雇主必须为收入五千令吉及以下的雇员缴纳从十二巴仙提升至十三巴仙的公积金。

国家最低工资委员会在一片反对声浪中, 仍然于二零一二年四月三十日宣布大马半岛最低工资为九百令吉, 东马则为八百令吉。这些都在目前每月必须缴纳的社会保险金及人力资源发展基金以外。同时, 雇员已经由现有的高裁员福利和就业法令保护。

紧接下来政府又企图推行失业保险, 这意味着另一种强制性的经营成本。政府怎么可以强制并期望企业能不由自主地消化这些接踵而至、富强制性的经营成本呢? 更重要的是, 这等成本与生产力毫无挂钩。

In January 2012, employer's EPF contribution for employees receiving RM5,000 and below was increased from 12% to 13%.

On 30 April 2012, national minimum wage rates of RM900 for Peninsular Malaysia and RM800 for Sabah, Sarawak and Labuan were announced despite all objections raised. These are on top of the existing compulsory monthly contribution for SOCSO, PSMB/HRDF while businesses are guarded against high retrenchment benefits and Employment Act. What's next?

The Government now wants to introduce Unemployment Insurance, which means another compulsory cost to business and how can the Government expect businesses to digest all the sudden costs shovel down our throat? Especially so if the costs are not productive or promote productivity in nature?
